**1) Duration : 3 Years + 1 Year Internship**

**2) ELIGIBILITY:**

A pass in H.Sc./10+2 (or) an equivalent examination from a recognized Board with minimum 50% in aggregate. The candidate should have studied in Physics, Chemistry and any one of following:

Biology (or) Mathematics (or) Computer Science (or) Statistics (or)Electronics (or) Psychology(or) Biotechnology (or)any Science subject.

Candidates belonging to any State/ Union Territory of India only are eligible.
