- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Medical College.
 - ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that "their original certificates are deposited with Institute / College / University" shall **not** be allowed to take admission in the allotted Medical College.
- d) Every student shall pay the tuition fee and other fee, as prescribed by the University, within the due date notified.

- a) Candidates are advised to check the website of the MCC of DGHS (Directorate General of Health Services), Ministry of Health and Family Welfare, Govt. of India, New Delhi website: www.mcc.nic.in and College website: www.vmmckkl.edu.in from time to time.
- b) Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all eligibility criteria prescribed by the NMC and medical fitness of the candidates. Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the MCC of DGHS. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his / her admission will be cancelled without any notice.
