- a) Candidates are instructed to frequently visit the MCC of DGHS (Directorate General of Health Services), Ministry of Health & Family Welfare, Government of India, New Delhi website: www.mcc.nic.in and College website: www.vmmckkl.edu.in for regular updates, counseling schedule and other information from time to time.
- b) Provisional Allotment letter given by the MCC of DGHS for admission to MD/MS Degree programme is subject to the fulfillment of all eligibility criteria as prescribed by the National Medical Commission, New Delhi and candidate's medical fitness. Those who fail to meet the prescribed eligibility criteria and are medically unfit will not be admitted to the programme. Furthermore, if it is found at any stage that a candidate has given false information, forged / fake certificates (or) concealed material information, his / her admission will be cancelled immediately without prior notice.
